# REPORT - INTERNATIONAL SUMMER SCHOOL IN REFUGEE LAW AND RIGHTS Olomouc, 10-19 of August 2018

#### About the school

The International summer school in refugee law and rights organised during August 10-19, 2018 by the Humanitarian studies section team of KKS at CMTF, springs from a tradition founded in Sarajevo, 2012 by Dr. Selma Porobić and late OBE Prof. Emerita Barbara Harrell-Bond from the University of Oxford. This school is modelled according to international summer schools from Refugee Studies Centre, University of Oxford, initiated by Prof. Emerita Barbara Harrell-Bond in 1980s as a pioneering academic refugee law training for the humanitarians. From the very start the summer schools in Sarajevo gathered scholars and professionals from all over the world and earned respectful international reputation. This was the 5th international summer school with the 10-days programme entirely dedicated to refugee legal protection with the European regional focus on the asylum right. The previous schools were co-organised and implemented with late Professor Harrell-Bond. This year's school was not to be an exception. 85-year's old, Professor Harrell-Bond was included in the organisational support and was planned to join the school program per Skype on the closing day of the ceremony, 19th of August.

Professor Barbara passed away on 11th of July in her home in Oxford, and this school was fully dedicated to honour her life and work. She has been a driving force behind refugee rights across the world since 1980s, and instead of the closing session she aimed to deliver on the 19th of August, we screened the specially commissioned film: 'Barbara Harrell-Bond: A life not Ordinary ' with permission of the director, Dr. Katarzyna Grabska. After the screening, Dr. Porobić and Dr. Maschovich shared their experiences of long-term work and friendship with late Professor Barbara Harrell-Bond.

#### School aim

From its start the schools' primary aim has been to bring together the leading academics and the practioners in providing the students with a blend of theoretical and practical considerations, illustrating the ever growing importance of this field in Europe and globally, and focusing the multiple aspects how they can proactively contribute to the refugee protection in their own countries through their future carriers in academia, UN, governmental and nongovernmental organisations, media and other.

# **School program**

During the ten-days-program led by Dr. Selma Porobić and Dr. Marko Szilveszter Maschovich, the participants were introduced to the selected aspects of this complex sociolegal area especially in consideration of the recent migration phenomenon evolving in Europe. As Innovation Officer at the Global Protection Cluster, United Nations High Commissioner for Refugees, Geneva, Dr. Macskovich aims to harness the phenomenon of innovation to enhance the protection delivery practices and policy towards war-displaced persons globally. His experience and competence from the field was invaluable to this year's school. He covered wide area of topics: from who refugees are, and what are the cornerstones enshrined in the 1951 Convention, to focusing on the "particular social group" ground of the Convention and discussing the challenges and specifics of refugee claims based thereon. Putting the theory into context, he also provided selected insights on the past and present dynamics of the shrinking asylums space in Hungary. Although the school's main focus was on refugees, he also incorporated a lecture on Internally displaced persons and the protection mechanism available for them.

Another two core lecturers of this year's school were Professor Dr. Iris Goldner Lang, Jean Monnet Professor of European Union Law and UNESCO Chair on Free Movement of People, Migration and Inter-Cultural Dialogue, from Faculty of Law at the University of Zagreb, and Mgr. Radostina Pavlova, Juris Doctor, Faculty of Law at the University of Toronto, Expert and Advocacy Officer at the Center for Legal Aid - Voice in Bulgaria (CLA).

During the two-day intense distance teaching per Skype, Professor Lang provided a critical approach to EU Asylum Law and its current challenges, focusing on the figures and political narrative in regards to incoming refugee flows, legal framework for EU migration and asylum policy, legal effects of refugee inflows on Dublin Regulation, as well as the national asylum standards and practices and those of Schengen Regulation. In a much appreciated interactive manner she brought students closer to the EU refugee responses and the changing paradigm

of EU law focusing also on the role of Court of Justice of the European Union and the effects of the Western Balkan Route.

Dr. Pavlova's teaching evolved over three intense days when she covered the complementary protection instruments such as the Humanitarian Law and International Human Rights Law but also Internal relocation and credibility issues in asylum claims, as well as detention of refugees in international law and in the EU directives. She also provided the excellent country specific focus on the Asylum system in Bulgaria and human rights violations though push backs that take place there.

A number of dedicated local contributors, such as Kristýna Andrlová, from UNHCR Office in Prague, Stanislava Sládeková, from OPU in Brno and Tomaš Jungwirth from the Czech Consortium of Migrants Assisting Organizations, provided an in-depth overview of protection practices in the Czech Republic. They both focused on the key aspects of the capacities for protection and used the redacted case-studies from the asylum procedures to engage the students in critical understanding of the current system procedural aspects at work. In the round table debate that we organised with these participants the issues of media, failed refugee reallocation scheme to Czech Republic and widely spread anti-migrant sentiments were discussed as well.

Together with these outstanding contributors bringing the passion and excellence of their work as experienced scholars, NGO legal advisers, law practitioners and policy advocators into the classroom, the Humanitarian studies section's lecturers and organisers of the international summer school 2018, were able to address the core building blocks of international refugee protection within the context of current EU asylum law - one of most challenging and charged topics of the contemporary humanitarian studies field.

The one-day simulation exercise adapted from Angolan refugee crisis, co-organised with Fire Rescue Service of the Olomouc Region and lead by Veronika Šťastná drawing from her mission for People in Need, was an excellent closure of the school program bringing us back to the field and providing hands-on experience of the response in the refugee influx situation.

#### Certificates and closing ceremony

Formal assessment of the students' performances consisted of the in-class discussion and assignments with a final performance on the simulation exercise, based on instructions received on the first day of the school and a guided group preparation. Upon successful completion of the school the participants were awarded with 12 ECTS points and the Graduate Participant Diploma.

During the closing ceremony, the students received **the Graduate Participant Diplomas** issued by the Sts Cyril and Methodius Faculty of Theology. Student evaluation of the school took place by means of anonymous surveys after which the documentary 'Barbara Harrell-Bond: A life not Ordinary 'was screened and followed by Dr. Porobić and Dr. Maschovich afertalk about work and friendship with late Professor Barbara Harrell-Bond.

Head of the Department, Dr. Mutalayova joined in for the closing session and thanked all the lecturers, organsier and students for the outstanding contribution to the school, first time organsied at CMTF, at the Palacky university and in Olomuc, Czech Republic. Dr. Porobić thanked her co-workers and expressed special thanks to Veronika Šťastná on behalf of the Department for her contribution to the Humanitarian studies section, whishing her good luck with the continuing career as a humanitarian worker in DRC. A group photography session by university photographer closed the school.

# **Participants**

This ten days' course brought together 21 participant consisting of academics, activists, lawyers, students, NGO workers, humanitarians, volunteers and professionals from many different countries: India, Slovenia, Croatia, Bosnia and Herzegovina, Bulgaria, Belgium, Spain, Netherlands, United Kingdom, Georgia, Ukraine and Czech Republic. The school provided full schlarships to eight of the Master program students from the Danube region through CEEPUS grant (Ministry of Foreign Affairs, Czech Republic) fully covering their school costs, residence and travel.

#### **School Evaluation**

The students evaluated the school with final score of <u>98%</u> for Excellence for all the segments, including academic content and program, special evening events, quality of lecturers, organisation, logistics, length, location.

In general, the students 'inputs and a great dedication to the school involving the serious approach and informed questions, made the program itself as successful as it was!
